Facebook Phishing Scam

Have you ever received a message in Facebook Messenger telling you your account will be permanently suspended? I am warned almost monthly that my account has violated community standards, there is unusual activity on the account, or my ads contain trademark violations.

These messages appear real. They say the sender is "Meta Verified", have all of the logos, the formatting looks legitimate. But, the email is just a phishing scam. After a closer look, I can usually find spelling errors, notice the user the message is coming from doesn't seem legitimate, and I remember that I have never once placed an ad on Facebook. They are also directing me to click on a link to resolve the "issue". This is the most obvious red flag.

Just like any other messages I receive, whether it be through email, text message, or voicemail, the same screening applies.

- PAUSE
- Does the message contain red flags?
 - Sense of urgency
 - Spelling errors
 - Contain a link or button

If you are unsure about a message, no matter how it is received, take the time to review it carefully. Get the opinion of a trusted family or friend. If you have determined it seems "phishy" don't be afraid to simply delete and continue on with your day.
